Consumer Price Index : September 2025

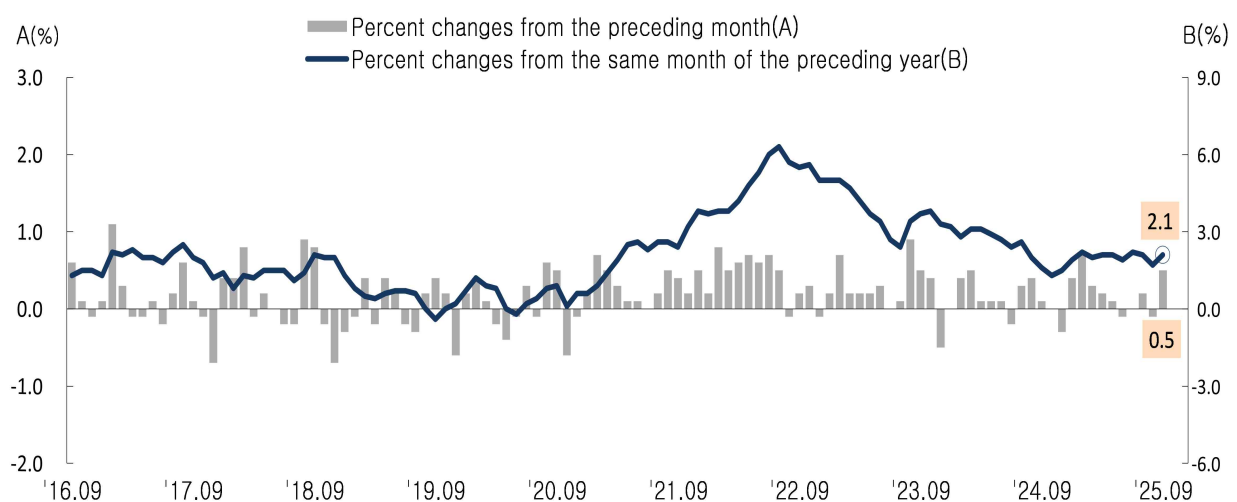
- The Consumer Price Index was 117.06(2020=100) in September 2025. The index increased 0.5 percent from the preceding month and rose 2.1 percent from the same month of the previous year.
- The index excluding food and energy was 113.36 in September 2025. The index increased 0.5 percent from the preceding month and rose 2.0 percent from the same month of the previous year.

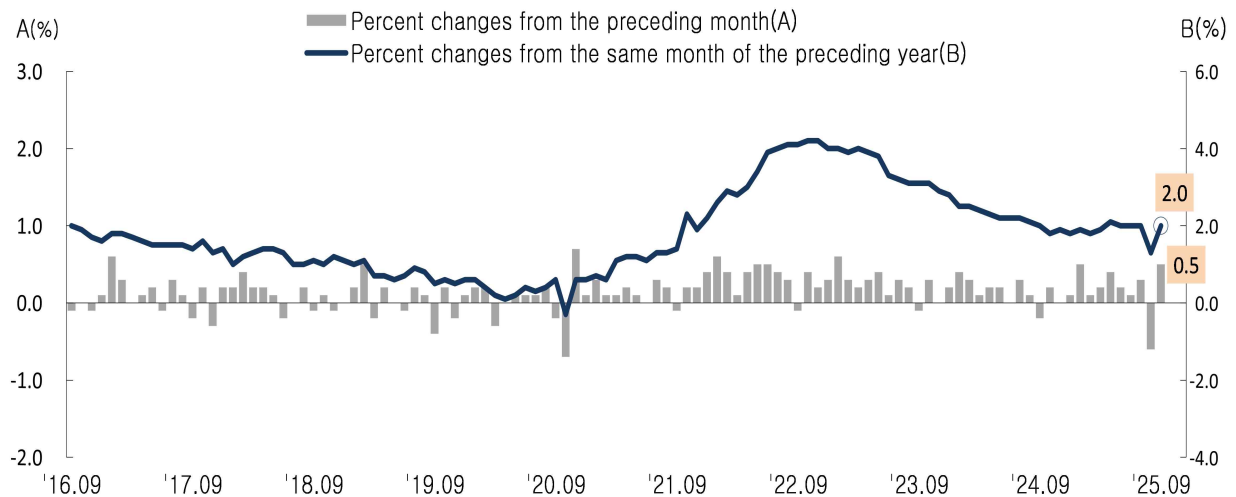

☐ The Consumer Price Index by expenditure category in September 2025 was below.

- The index for Alcoholic beverages and tobacco, Housing, water, electricity, gas and other fuels, Communication, and Miscellaneous goods and services increased 0.1 percent, 1.2 percent, 15.4 percent, and 0.2 percent respectively from the preceding month.
- The index for Food and non-alcoholic beverages, Furnishings, household equipment & routine maintenance, Health, Transport, Recreation and culture, Education, and Restaurants and hotels decreased 0.1 percent, 0.8 percent, 0.1 percent, 0.9 percent, 0.7 percent, 0.3 percent, and 0.3 percent from the preceding month.
- The index for Clothing and footwear remained unchanged from the preceding month.
